Thematic issues

Many authors have characterized our epoch as "Epoch of turbulence" (as Alen Greenspan argues in his book "The age of turbulence ([2007], 2011). The Central Theme of 10th Conference of European Sociological Association, ESA (Geneva - Switzerland, 7-10 September 2011) is "Social relations in turbulent times". One of the most prominent characteristics of our time is "uncertainty". The world economic crisis, the social and political movements of various countries etc., are only some of more visible features of our time. The term "risk society" is being articulated more and more...

One of the questions is how the developments of our time affect education. At the same time education is considered as a kind of "universal solution" for social problems and private concerns (in terms of Mills).

Through this conference AIS aims to establish a permanent cooperation between sociologists, social scholars and other stakeholders in the field of Education in Albania, in the Balkan region and wider; the focus of researches and debates will be on issues of education and promoting sustainable development in the field of education.

Why education first?

Because general transformations are affecting the sustainability and quality of education (1) and, simultaneously, are affected by it; (2) in the past two decades major reforms have been undertaken in the educational institution all over the world; (3) education may sometimes lead to undesirable and contradictory results (4), quality education is seen as a "universal cure" to resolve the major problems of our time and to confront future challenges (5) it is recognized as a 'cure' for unemployment, 'tool' for social cohesion, 'investment' in children's future.

With reference to Albania, two decades of Post-Communist transition represent in itself a "turbulent time". Drastic transformations are made in the field of education. But quantitative changes have generated significant problems in terms of quality issues.

The results of a national survey undertaken by IS, in 2010, highlight the following issues: (1) the quality of education not only is considered a "social problem", but even ranks first in the hierarchy of social problems at the moment; (2) the public concern index in regard to poor level of education, is higher than public concern index for many other social problems; (3) a number of other social issues are perceived to have a direct, or indirect connection with the schools and teachers; (4) referring to public expectations, quality education is also considered as key to solving other social problems such as poverty, etc.; (5) teaching is gradually becoming "an abandoned profession" (only 0.8 percent of 2010 graduates have selected "teaching" as first preference for university studies); (6) education is likely to enter into a cycle with detrimental consequences for the future of Albania and the prospect of its European integration.

The study of these issues is one of the most important tasks of sociology and other social sciences. Albania can also be considered as kind of "laboratory" for studies, in sociology and other social sciences. The Albanian case is significant for the study and treatment of problems faced by other countries of the Balkans, Europe and beyond.

The Social Pathologies of Contemporary Civilisation

September 15th & 16th, 2011

The School of Sociology & Philosophy, University College Cork, Ireland, & The Danish Centre for Philosophy and Science Studies, the working group on Psychiatry & Society, Department of Sociology, Social Work and Organization, Aalborg University, Denmark, are organising a conference entitled *The Social Pathologies of Contemporary Civilisation*. The Conference will be held in University college Cork on september 15th & 16th, 2011. We hoped that you would add our conference information to the website of the European Sociological Association.

This conference focuses the social pathologies of contemporary civilisation, i.e. on the ways in which contemporary malaises, diseases, illnesses and psycho-somatic syndromes are related to cultural pathologies of the social body and disorders of the collective esprit de corps of contemporary society manifest at the level of individual patients' bodies, and how the social & bodies politic are related to the hegemony of reductive biomedical and individual-psychologistic perspectives. The central research hypothesis guiding the conference is that many contemporary problems of health & well-being are to be understood in the light of radical changes of social structures & institutions, extending to deep crises in our civilisation as a whole. Problems of health and well-being have hitherto been considered in isolation; both in isolation from one another, and in isolation from broader contexts. The human person is an indivisible whole, the functioning of the body as an organism is intrinsically linked to the functioning of its mind, and even its 'soul' or 'spirit'. Health and well-being are not just located at the level of the individual body, the integral human person, or even collective social bodies, but encompass the health of humanity as a whole and our relationship with Nature. Recovery of our individual and collective health & well-being needs to be conceived of with such a holistic context, encompassing the importance of grace, beauty and meaningfulness to human flourishing. A particular focus of the conference is the role of humanities and social sciences, particularly sociology, philosophy and anthropology, in helping to understand the connection between individual & collective experiences of social transformations and of health & well-being.

We invite abstracts of not more than 300 words related to any of the above themes to be submitted not later than April 29th 2011 to the email address below. All abstracts will be subject to peer-review and should be sent to the conference organisers at tspocc@gmail.com

Symposium: "Paul Felix Lazarsfeld – His Methodological Inspirations and Networking Activities in the Field of Social Research"

Prague, Czech Republic

September 25-27, 2011

110 years have passed since the birth of Paul Felix Lazarsfeld in Vienna (13.2.1901) and 35 years have passed since his death in New York (30.8.1976). P. F. Lazarsfeld was an 'organizational man'. He founded four research institutes – in Vienna, Newark, Princeton and New York – during the 45 years of his active scientific career. He developed an unprecedented network of social scientists, ranging from the fields of sociology, social and developmental psychology to history, communication science, demography, social anthropology, and philosophy, to mathematics and statistics and the Frankfurt School of criticism, and he established many ties between Europe and America involving Vienna, New York, Paris, Oslo, Palo Alto, Rome, Chicago, Warsaw, Washington, Moscow, Princeton, and even Prague. He and his close fellow-workers inspired two generations of social scientists in the field of Research Methodology. His research, educational, scientific and organizational activities served to unify social research for almost 45 years, from the time of his famous Marienthal study, using both quantitative and qualitative methods, to his UNESCO seminars in the 1970s in Eastern Europe.

This small symposium follows from the successful WAPOR Thematic Seminar "The Early Days of Survey Research and Their Importance Today", which was held in Vienna on July 1-3 2010.

It is hard to imagine the historical development of the field of survey research and the methodology of empirical social research, including public opinion research and market research, without invoking the name of Paul Felix Lazarsfeld. We would like to celebrate his mastery of all the scientific fields that he helped advance during his scientific career.

The purpose of this thematic seminar is to help develop an understanding of the many sources of inspiration and ties that helped to develop and unify social science methodology thanks to P. F. Lazarsfeld's research and organizational activities.

The event is being organized by the Faculty of Social Sciences at Charles University in Prague in cooperation with the Faculty of Social Sciences at the University of Vienna and WAPOR and it is taking place in Prague in the heart of Europe.

We welcome any papers dealing with our two main topics: 1) the sources of inspiration of P.F. Lazarsfeld and his school of Social Research Methodology, and 2) the fascinating figure's social or research networking activities anywhere in the world.

"Religions as Brands". The Marketization of Religion and Spirituality

University of Lausanne, October 13-15, 2011

Deadline for submission of abstracts: April 30, 2011

Theme

This international conference deals with religious markets and how religions try to market and brand

themselves. In the market of religions paradigm, economic and marketing vocabulary are used to

analyze the religious domain. Religious organizations are seen as "firms", while the faithful are seen

as "consumers" of both this-worldly and otherworldly "religious products". Religions may then be

analyzed as "brands" conveying specific brand experiences and images. Religious specialists engage

in "branding" their specific group and market their specific offer, aiming for converts, participants,

donators and public recognition. However, religions and religious groups may also have to face

negative publicity due to scandals, suboptimal performance, lack of integration or religious conflict.

Some religious groups may find it a challenge to adapt to modern conditions and to market

themselves, while others may try to resist to see their offer as "products".

This conference welcomes papers dealing with the topics listed below. Papers may focus on all kinds

of religions, "world religions" just as new religious movements or alternative spiritualities. The

conference is an interdisciplinary academic venue between sociology, economics, marketing, and

study of religions scholars, open to all, supporters as well as critics of the economic paradigm of

Please, provide full names, affiliations and up-to-date contact details (postal address, e-mail, telephone and fax numbers).

- The editors of **Journal of Consumer Culture and Consumption**, **Markets**, **and Society** encourage submission of papers from the "Religions as Brands" conference.

Language

Abstracts and final papers may be submitted in English, French, or German. Since English is the shared language of the Conference, presenters are expected to make their presentation in English for making cross-language communication easier while retaining some key concepts in the original language for the purpose of highlighting culture and language-specific concepts that are not cross-culturally equivalent.

Submission Format

All abstracts and final papers in Microsoft Word format can be submitted in English, French, or German, checked for correct grammar and spelling. Four years after the first meeting, the Second International Conference of Young Urban Researchers (SICYUrb) provides continuity to the experience of interdisciplinary meeting of young urban researchers. Once again, the University Institute of Lisbon (ISCTE-IUL) hosts this event, held in Lisbon from 11 to 14 October 2011.

Second International Conference of Young Urban Researchers (SICYUrb) aims to gather recent researches on urban contexts from many different areas of social sciences, to discuss current theoretical and methodological issues and to promote interdisciplinary and international networking. It is intended that the meeting should be boosted by young researchers who work in urban studies and develop research in the cities - especially those who are studying in post-graduate programs but also those carrying out technical and intervention activities.
